ANNUAL IMPACT REPORT

Generations United had an incredible year. We're proud to highlight ten of our top accomplishments and invite you to join us in strengthening intergenerational connections in 2023. Your support helps us continue creating meaningful programs, initiatives, and partnerships that bring generations together and build stronger communities.

Highlights

- 1** Launched the Grandfamilies & Kinship Support Network: A National Technical Assistance Center, a five-year cooperative agreement with the U.S. Department of Health and Human Services, Administration for Community Living to provide technical assistance to an array of government agencies and organizations that serve kinship families.
- 2** Strengthened our Diverse Intergenerational Programs Initiative by surveying the field, updating our Programs of Distinction Certification, and hosting a webinar on Cultural Responsiveness and Intergenerational Programs.
- 3** Supported the development and release of a national caregiver strategy created as a result of the work of The Federal Advisory Council to Support Grandparents Raising Grandchildren.
- 4** Elevated the importance of different intergenerational housing models by co-hosting a successful webinar with the Joint Center on Housing Studies at Harvard University and Nesterly and convening the first learning network on the topic.
- 5** GRAND Voices Network members engaged to improve policy, practices and research, informed GU resources, provided peer support and participated in White House Conference on Food, Nutrition, & Health listening sessions.
- 6** Released the 2022 Annual State of Grandfamilies Report, Together at the Table: Supporting the Nutrition, Health, and Well-Being of Grandfamilies.
- 7** Celebrated Grandparents Day 2022 with an expanded campaign and release of our updated Take Action Guide.
- 8** Convened the Shared Site Learning Network to help disseminate information from our online toolkit.
- 9** Created a on-line hub for intergenerational information in Michigan and launched the Ypsilanti IG Community Solutions Institute with Eastern Michigan University to spark collaboration.
- 10** Testified before the Senate Committee on Aging as an invited bi-partisan consensus witness speaking about the impact of COVID-19 on grandfamilies.
