2005-Generations United applies for and is granted NGO Consultative Status with the United Nations. Kevin Brabazon becomes GU's first volunteer representative

2006- Chaired the Committee on Social Integration and helped plan and moderate "Multigenerational Perspectives on Migration" seminar UN Headquarters

2007-Invited to Expert Group Meeting on "Intergenerational Solidarity: Strengthening Economic and Social Ties." Wrote background paper later included in an edited book resulting from the meeting. Intergenerational photography exhibit created and displayed at the UN Headquarters

2008-Moderated "Multigenerational Perspectives on Human Rights on Young and Old" seminar at UNESCO in Paris, France

2009- Participated in the Subcommittee on Multigenerational Relationships of the NGO Committee on Aging

2010- Coauthored "Policies and Programmes Supporting Intergenerational Relations" one of the three background papers to be featured at the 20th anniversary of the International Year of the Family at UN Headquarters in 2014

2011-Attended, wrote background paper and presented at the "Dialogue and Mutual Understanding Across Generations" convening in Doha, Qatar
